# **CAFO/ Operations Ordinance Committee**

The committee met 0n January 13 at The Rock Elm Methodist Church. They had some Public Input at this meeting concerning farm trespassing issues. This will be researched and addressed at their next meeting. Concerning Application and renewal fees, there was a lengthy discussion and \$1.00 per animal unit is the current thought to be used for outside sources so there are no costs to the township.

Their next meeting is scheduled for February 10 and they hope to have an ordinance to present to the Town Board at the February meeting.

### **Highway Report**

Presented by Dave Bechel, Patrolman. He has been dealing with snow, ice and freezing fog. Pierce County Highway Department will be boom mowing soon. \$10,000 for this were in the 2025 budget. Finished installing the wing on the grader.

12-30-2024 When Dave checked the roads he found a chain up on 410<sup>th</sup> Ave Dead end. Tim was called, he called the landowner in Chicago who said he appreciated the town plowing the road and would move the chain.

1-9-2025 Tim and Dave looked over spots for boom mowing and set up a priority list.

Dave has talked to Schalles Gas pertaining to filling and delivering lp cylinders used on the hot box for road patching. The cost is \$125 per cylinder, delivered with 6 cylinders. So a start up cost of \$750 and they will replace when 4 cylinders are empty. This would save money and be safer.
