Tim Bates called the meeting to order at 8:00 PM

Motion to approve the agenda was made by Matt Holcomb and seconded by Tim Bates, motion carried.

Minutes from the Previous Meeting

Minutes from the caucus held January 14, 2025 meeting were read. Motion to approve by Matt Holcomb, second by Tim Bates, motion carried. The minutes from the caucus were not read at the February 11 meeting by mistake. Minutes from the February 11 meeting were read, motion to approve by Matt Holcomb, seconded by Tim Bates, motion carried. Minutes from the February 25 meeting were read, motion to approve by Tim Bated, seconded by Matt Holcomb, motion carried.

Public Input

Venture Dairy Coop representative Delanie Breuer—deals in pro-ag policies, has looked over the proposed ordinance and is at our meeting to "set the record straight". A similar ordinance in Eureka in Polk County is facing litigation. She says some portions of this proposed ordinance are unlawful. Stated that the state has strict water and air regulations. Stated that WMC attorneys are good but she is better and the Town Board will be caught in the middle. She said our concerns cannot be based on "what could happen".

GROWW representative—stated that Venture has a history of scare tactics and are against the DNR. He stated the litigation for the Town of Eureka has been thrown out of court once.

Nonresident-- but close neighbor to Ridge Breeze was inquiring if this dairy would cover the cost of new wells if current ones are contaminated?

Ridge Breeze representative—stated there were other avenues to accomplish the Town's concerns, they have an "open door" policy and can tell us surrounding townships to their current large facilities.

Non-resident—stated that Clam Falls Township had spent a lot of time on this issue but in the end left it behind Non-resident—said all the cards were in the corporations favor at the federal, state and county levels, so what's the big deal in having an ordinance

Non-resident—felt that small farmers are going to be driven out

Non-resident—asked about accountability and the protection of a bond

Non-resident—from Venture, farming is not what you are used to

Town board member—we are looking at the "what ifs"

Resident—commended Dave Bechel on his care of our roads in all weather

Non-resident—Dairy Business Association—would work with us for grants

Resident—we are the same people as in the past and want a good working relationship with the town Board member—if the public sees problems with other drivers etc. they should call it into the Sheriff's Department

Report from Spring Valley Schools Administrator

Due to illness their representative was unable to attend.

CAFO Ordinance

The Chairman had asked Attorney Loberg questions after the February 25th meeting. He is working with several townships. Some of this is new stuff that has not been challenged in court yet. He suggests raising the amount of fines.

Financial Reports

Monica Robey presented the financial reports. This month's total of bills to be paid was \$96,931.30, which includes \$82,838.18 as the annual loan payment. Chris Thibado made a motion to approve, Matt Holcomb seconded, motion carried.

Contract with Darel Hall, Dedicated Animal Control Service

As part of trying to resolve the issues of animal control, Darel Hall would provide a service as Animal Control/Animal Humane Officer. He would bill the town and the town in turn would bill the animal owner. If unpaid it could be a special assessment added to property taxes. Chris Thibado made a motion to accept the Animal Control Officer Agreement with Darel Hall, seconded by Matt Holcomb, motion carried.

Highway Report

Presented by Dave Bechel, Patrolman. He has been dealing with the snow. 1-27-25 Dave serviced the pickup

- 2-18,2-19, 2-20—Tim and Dave looked over boom cutting done by Pierce County Highway. They were very happy with the work done by Brian Kusilek.
- 2-24-2025 Tim and Dave met with Brian Brunner from Schmitt Timber on logging on 190th Street (Skunk Hollow) 570th
 - 3-3-2025 Installed road restriction signs.
 - 3-5-2025 Lance Elbe came in to help with snow, he ran the truck while Dave ran the grader.
- 3-11-2025 Tim and Dave looked over a possible driveway location on 190^{th} Street (Skunk Hollow) for Neil Kurzejeski. It would need an $18'' \times 30'$ culvert Motion to approve by Chris Thibado, seconded by Matt Holcomb, motion carried.

Tim Bates reported that the Salt Shed doesn't pass the code. They are now doing twice a year inspections. They want doors on the shed. Truck drivers are asking for permission to use restricted roads on a limited basis. A couple have asked for permission on the town letterhead, which brings up creating a letterhead. Designs by Jill was contacted about it.
